**Afghanistan, Argentina** (only **Business, Tourist & Transit Visas** on gratis basis to nationals of Argentina. Normal visas fee is applicable for all other type of visas ), **Bangladesh, DPR Korea, Jamaica, Maldives, Mauritius, Mongolia, South Africa, Uruguay** (only **Tourist Visa** on gratis basis for Uruguay nationals and normal visa fee is applicable for all other type of visas ) and **Seychelles (Tourist Visa upto 3-months only)**

**Nationals of Nepal and Bhutan** do not require visa to enter India. However, Nepali nationals require visa if they enter India from China, which is gratis.

**Visa fees for Pakistani nationals : Rs. 100/- = Ar. 17,000/- (inclusive of ICWF Fee i.e. Ar.11000/-)**
